The meeting discussed the following points:

1. The meeting started with the welcoming of the internal and external members along with student members by the Convener Dr. R.M. Metkar. Council members Mr. Ranjeet Band and Prof. D.R. Uike were permitted leaves due to their urgent matters.
2. Principal, GCoEA suggested for creation of Innovation Ambassadors from GCoEA to be amongst the council members. He suggested that the core council members should take up the role of Innovation Ambassadors from GCoEA.

3. Principal, GCoEA has directed Prof. P.P. Shelke, Social Media Coordinator to create a tab on GCoEA website that highlights the achievements and publications of IIC so that it reaches to everyone and all our stakeholders.
4. Principal, GCoEA has asked Dr. M.V. Jape IPR Activity Coordinator to conduct an IPR related workshop in the month of December, 2022 and in February, 2023.
5. Mr. Swapnil Gawande, IP Expert/ Patent Expert suggested that our institutional projects to be in line with the concepts of start-ups and be oriented to possible patenting. He was of the opinion that these preliminary steps would create a stage for students to improve upon their ideas. These ideas would eventually end-up in creating good projects and other exemplary aspects.
6. Mr. Pranav Sontakke, Deputy Manager, FI/Bank/Investor/Angel Investor/VC highlighted that a mentor pool of faculty and students be created for propagating the idea of good and patentable projects that have the potential of attracting findings from various funding agencies.
7. Mr. Pranav Sontakke said that financing is available and various schemes can be utilized by faculty and students. He elaborated on the Govt. of India and SBI India policies that provide for Credit Guarantee scheme with Rate of Interest 08.40% under the CGTMS scheme. These finance scheme funds for green field projects that contain a versatile idea.
8. Dr. Swati Sherekar, Director, Innovation, Incubation & Linkage, SGBAU, Amravati praised and appreciated the ongoing working of IIC Council of GCoEA. She suggested that this council should focus towards IIC 5.0 of Ministry of Education, Govt. of India.
9. Dr. Swati Sherekar suggested that activities and events to be organized in the institution and council members should attend such type of activities and events being organized by other institutions within and outside the state. This shall play a vital role in enhancing the capacities of the faculty and students.
10. Dr. Swati Sherekar suggested that GCoEA IIC council should be in touch with the Amravati's Maharashtra Centre for Entrepreneurship Development (MCED) and collaborate with it for projects and other activities.
11. Principal, GCoEA suggested that all the departments of GCoEA should look forward to the multi-disciplinary projects in the future in line with IIC mandate.
12. Student members requested for being provided with financial support for competition, visits, travel grant and stay grants for the events and other competitions within India as per institutional R&D policy. The President has agreed for students and has suggested that faculty members be also taken under the ambit of this kind of financial supports under the institutional R&D policy for faculty members.
13. Dr. R.M. Metkar, Convener, IIC has suggested for creation of NISP policy in the institute.
14. Dr. S.A. Lohi proposed the vote of thanks to all the members. The meeting ended with good note and with a resolution to work towards furthering the idea of IIC.
