MEMORANDUM OF UNDERSTANDING (MoU)

BETWEEN

Government College of Engineering, Amravati (M.S.) AND NLMK India Coating Private Limited, Aurangabad

This Memorandum of Understanding (hereinafter called as the 'MoU') is entered into on this day and date the, Fifteenth of March 2024 - 15.03.2024 by and between Government College of Engineering, Kathora Naka, VMV Road, Amravati-444604 (M.S.), represented herein by its Principal, Dr. A. M. Mahalle, hereinafter referred as Engineering College or First Party,

And **NLMK India Coating Private Limited**, a company incorporated under the provisions of the Companies Act, 1956 represented through Mr. Vivek Solanke, Head HR and IR hereinafter referred as NLMK or The Second Party, (which expression shall unless repugnant to the context mean and include its successors transferees, assigns etc.)

WHEREAS:

- A) First Party is a Higher Educational Institution named: Government College of Engineering, Amravati (M.S.)
- B) First Party & Second Party believe that collaboration and co-operation between themselves will promote more effective use of each of their resources, and provide each of them with enhanced opportunities.
- C) The Parties intent to cooperate and focus their efforts on cooperation within area of Skill Based Training, Education, Placement, Industrial Visit, Expert Lecture.
- D) NKMK India Coating Private Limited the Second Party is engaged in the field of Producing Grain Oriented Electrical Steel, also as NLMK Brand is engaged in the vertically integrated business from mining to production of special steel.

NOW THEREFORE, IN CONSIDERATION OF THE MUTUAL PROMISES SET FORTH IN THIS MOU, THE PARTIES HERETO AGREE AS FOLLOWS:

CLAUSE 1 CO-OPERATION

- 1.1 Both Parties are united by common interests and objectives, and they shall establish cooperation.
- 1.2 First Party and Second Party co-operation will facilitate effective utilization of the intellectual capabilities.
- 1.3 The parties shall co-operate with each other and shall as promptly as is responsibly practical, relevant agreement.

CLAUSE 2 SCOPE OF THE MoU

2.1 Internships, Industrial Training & Visits: Industry and Institution interaction will provide an insight into the latest developments / requirements of the industries; the Second Party to permit the Faculty and Students of the First Party to visit its group companies and also involve in Industrial Training Programs / Internships for the First Party. Full-Semester/2-Month Internships for final year/pre-final year students will be offered at the production plant of Grain Oriented Electrical Steel based on the selection process to be mutually agreed upon by both the parties. The number of such internships to be offered and the schedule/duration of the internship will be mutually finalized and exchanged formally in writing. Full-time internships will be for the entire duration of 8th semester and will result in a project work to be evaluated by jointly by the internship supervisor and institute mentor/guide. This will provide confidence & smooth

transition for students' work. Also the Second party may register on the AICTE Internship Portal for the benefit of students.

- 2.2 Guest Lectures: Second Party may extend the necessary support to deliver guest lecturers to the students of the First Party on the technology trends and in house requirements.
- 2.3 **Placement of Interns/Trained students**: Second party will actively engage to help the delivery of the training / internships and placement of the students of the first party on the technology trends and in house requirements.
- 2.4 There is no financial commitment on the part of the Government College of Engineering, Amravati (M.S.), the first party to take up any program mention in MoU. If there is any financial consideration, it will be dealt separately.
- 2.5 Both Parties to obtain all internal approvals, consents, permissions, and licenses of whatsoever nature required.

CLAUSE 3 VALIDITY

3.1 This Agreement will be valid for two years from the date of execution it may expressly terminated by either Party by giving one month notice to other party, both the parties may renew the same on mutually agreed terms, during which period, the Second Party will conduct the activities.

CLAUSE 4 RELATIONSHIP BETWEEN THE PARTIES

4.1 It is expressly agreed that First Party and Second Party are acting under this MoU as independent contractors, and the relationship established under this MoU shall not be construed as a partnership.

CLAUSE 5 CONFIDENTIALITY AND NON DISCLOSER

5.1 It is expressly agreed that First Party and its students shall not disclose or divulge the proprietary information, drawing, data designs and/or any products and trade secrets and confidential technical and commercial information of the NLMK to anybody else at any time.

CLAUSE 6 INTELLECTUAL PROPERTY RIGHTS

6.1 It is expressly agreed that NLMK shall be entitled to the technical information, intellectual used by the intern or technology or knowledge imparted by the First Party to Second Party, there should not be any claim arise out of this MoU.

CLAUSE 7 MUTUAL REPRESENTATION

7.1 It is expressly agreed that there is no reciprocal gurantee or presentation or assurance from NLMK to hire any resource from the First Party. NLMK may explore and hire talent only as per the policies of NLMK.

CLAUSE 8

INDEMNITY

8.1 It is expressly agreed that both the parties indemnify each other and keep harmless to other party. NLMK shall engage interns as per the policies of NLMK and amy cancel without assigning any reason.

This Agreement is executed at RGSTC Mumbai, this 29th day of January, Two Thousand Twenty Four,

between

The **Rajiv Gandhi Science and Technology Commission**, hereinafter called RGSTC, which is a statutory body set up by Government of Maharashtra under Maharashtra Act No. XV 2004 having its office at 3rd Floor, Apeejay House, Dinshaw Vachha Road, Near K.C. College, Churchgate, Mumbai – 400 020.

and

Government College of Engineering, Amravati, of Sant Gadge Baba Amravati University, Amravati hereinafter called the Academic Partner (AP) and having its registered office at VMV Road, Near Kathora Naka, Amravati-444604.

Whereas **RGSTC** has **evolved** a Scheme for Providing Technical Support to the MSMEs by Leveraging the Capabilities of Students and Faculty of Engineering & Technical Institutions called the RGSTC-MSME Internship Programme (**RMIP**).

Whereas RGSTC has adopted the TIFAC-MSME Internship Programme for implementation at additional institutions in Maharashtra and is called as RGSTC-MSME Internship Programme (RMIP).

Whereas RGSTC has selected **Government College of Engineering**, **Amravati** which is one of the Technical Institutions for providing technical and financial support, selected under RMIP Scheme.

Whereas RGSTC and the Academic Partner have agreed to collaborate to implement the RGSTC MSME Scheme and it is agreed that their collaboration would be mutually beneficial with the following objectives:

Objectives

- a) Creation of a platform for establishing interaction between academia and MSME industries on a mutually win-win basis.
- b) Establishing a platform for the MSME cluster industries to access R&D and technical support leveraging the knowledge base of faculty and knowledgeable human resource in the form of students from technical institutions.
- c) Providing hands on engagement and practical experience to the students and faculty on existing technical challenges in the industry and nurturing an innovation ecosystem that benefits both the industry as well as the technical institution.

Now, therefore, in consideration of the RGSTC agreeing to provide grants-in-aid for fulfilling the objectives of the scheme on the mutual covenants hereinafter contained, the parties hereto agree as follows:

1.0 The Role and Responsibilities and Deliverable of the AP (Government College of Engineering, Amravati) would be as follows:

1.1 1st Stage of the Scheme

- i) Interaction with MSME clusters/industries to get an initial feel of their technical problems/challenges and to decide on the placement of students with the industries.
- ii) Identification of appropriate students (Maximum 30 in one year) from Technical Institutions to be placed in nearby industries based on the requirement of

- industries. The AP to submit the list of students with details placed for internship in industries in the format to be provided by RGSTC.
- iii) Placing appropriate students (one or two) in industries based on student's background, interest and area of work of the industry.
- iv) Facilitating initial interaction of students with industries.
- v) Identifying technical problem/challenge of industries through students under the guidance of appropriate and experienced mentoring faculty.
- vi) Mentoring of students by faculty (one or two) towards defining the problem statement, defining a credible work plan for developing an appropriate low cost and easily adoptable, time bound solutions and preparing proposals based on such proposed solutions for consideration under 2nd Stage Variable Project Based Technology Development Support. The proposed solutions to comply with the type of solutions as mentioned in the detailed scheme document.
- vii) Preparing a report/booklet of the identified industrial problems by students and details of proposed solutions to be handed over to the industries and to RGSTC.

1.2 2nd Stage of the scheme

- i) Developing complete and finalized proposals based on comments and initial screening duly vetted by the concerned industry.
- ii) Presenting the proposals by faculty and students (along with concerned industry) to the Technical Screening Committee (TSC) constituted by RGSTC for the purpose of screening project proposals.
- iii) Once project is approved by the TSC and project grant released, developing practical low cost and easily adoptable solutions in the time bound manner (6 months) for the industries.
- iv) Monitoring the project and submitting timely progress reports to RGSTC and facilitating any project progress activity by RGSTC.
- v) Installing the developed solution in the industries for testing and trial as part of project activity.

vi) Submitting final project report endorsed by the concerned industry (ies) to RGSTC in the defined format as provided by RGSTC.

2.0 Financial Support and Terms and Conditions

2.1 The financial support from RGSTC will be provided to **Government College of Engineering, Amravati** in two stages as 1st Stage support and 2nd Stage support.

The 1st Stage support to be the fixed support, maximum of Rs. 4.32 lacs/annum to be provided to the AP, for facilitating and conducting internship of students in MSME industries towards identification and definition of industrial technical problems and development of appropriate problem statement along with the mentoring faculty.

The 2nd stage support of maximum of Rs. 2.95 lacs per project (RGSTC share) to be the project based variable technology development support to be provided to the sanctioned project depending on project work. The Project duration would be of 6 months (from the date of project sanctioning including testing/trial period in industry, if any required).

- the stipend may accordingly reduce proportionately. The Scheme Coordinator should certify presence of student in the industry.
- # The Institute may provide incentive to the mentoring faculty (ies) from the Institute Overhead as per its norms.
- ^ Travel cost to cover the cost of all travel related to this scheme under stage 1st.

Note: In case of less number of students are placed for internship in industries, the total Stage 1st fixed component support to be calculated accordingly.

Government College of Engineering, Amravati will provide a separate Utilization Certificate and Statement of Expenditure for the fixed support to RGSTC. Any unspent fund and accrued interest to be returned to RGSTC or adjusted against any further release. On signing of the Agreement, RGSTC would release an amount of Rupees Four Lacs Thirty Two Thousand Only (Rs. 4,32,000/-).

On completion of Stage 1st and review by RGSTC, the Institute shall submit Stage 1st Completion Report along with Utilization Certificate and Statement of Expenditure of the funds provided.

If more students are involved the industry or the Institute has to bear the additional cost, if any. In case the project duration is less than 6 months then stipend will be provided only for such project period. In case the project period is beyond 6 months, RGSTC will provide stipend for 6 months only.
- # The Institute may provide incentive to the mentoring faculty(ies) from the Institute Overhead as per its norms.
- ^ Travel cost to cover the cost of all project related travel activities under stage 2nd.

RGSTC to support a maximum of 3 projects per **AP** per year. Sanctioned project funds for each project will be released to the institute to undertake the project work.

2.2 Terms and Conditions

- 2.2.1. There should not be any deviation from the Budget Heads as approved by RGSTC. In case, if it is very necessary, a request can be made to RGSTC for consideration.
- 2.2.2. **Government College of Engineering, Amravati** will provide Quarterly progress report giving the progress of work as well as future action plan.
- 2.2.3. RGSTC will review the technical & financial progress including utilization of the grant on a periodic basis with an appropriate mechanism.
- 2.2.4 **Government College of Engineering, Amravati** to submit Utilization Certificate (UC) and Statement of Expenditure (SE) in the given format (Annexure 1) for the funds released to it by RGSTC separately for both stage 1st and stage 2nd of funding received from RGSTC. Unspent project fund to be adjusted further on or returned to RGSTC as the case may be.
- 2.2.5 Any assets acquired from the grant will be the property of RGSTC and should not, without the prior sanction of the RGSTC, be disposed off or encumbered or utilized for purposes other than those for which the grant has been sanctioned.
- 2.2.6 RGSTC, at its discretion, shall have the right to access the book of accounts of the **Government College of Engineering, Amravati** for this support. It is found expedient to keep a part or whole of the grant in a bank account earning interest. The interest thus earned should be reflected appropriately in the Financial Statement submitted to RGSTC.

2.3 Other Terms and Conditions

2.3.1 AP to open a separate bank account to handle RGSTC's support under this scheme.

- 2.3.2 AP to strictly adhere to RGSTC's guidelines for implementing this scheme.
- 2.3.3 AP to appoint a responsible and senior official (faculty or non faculty) for coordinating this scheme. The coordinator of the scheme will be the one point source /contact for all correspondences/communication and will be accountable to RGSTC for all matters related to this scheme.
- 2.3.4 The AP to work out a proper mechanism for engaging students from other regional Technical Institutes discipline wise also, if required.
- 2.3.5 The concerned department of the AP placing students in MSME industries for internship to be not less than 7 years old. AP to provide to RGSTC the details of all concerned Departments from which the AP desires to place the students for internship along with the details of students in the format provided by RGSTC.
- 2.3.6 In case, student interns are also sourced from other Technical Institutes, the concerned department of the AP to which such students are attached towards mentoring etc should be at least 7 years old.
- 2.3.7 AP may place any number of interns in the industries. However, the internship support from RGSTC will be for maximum of 30 student interns /year as per clause 2.1 of this Agreement as per the budget break up and support modalities.
- 2.3.8 The maximum number of projects to be taken up from each AP at a time to be not more than three.
- 2.3.9 AP will be responsible for all activities of the students pertaining to internship and projects during their internship as also during the project period. The internship as well as project work should be part of the academic requirement for the students for both students from AP or from other Technical Institutes.
- 2.3.10 Problems and solutions pertaining/related to pure software, arms and armaments and herbal formulation etc. and those requiring long term testing/trials will not be considered for support. The AP to also make sure that student interns are not placed to identify or define any such problem.
- 2.3.11 AP will be the owner of the solution or technology developed.

2.3.12 AP will be responsible for designing and delivery of appropriate technical solutions to the Industry through support from this scheme and also for any subsequent issues arising out of it, if any.

2.3.13 The AP to appropriately highlight the RGSTC-MSME Internship Programme in all related communications.

3.0 Ownership of IPRs generated

Ownership of the existing IPRs and of the IPRs generated out of the project, patent rights, licensing the know-how and the use of the know-how shall be decided between the Academic Partners and the Industries concerned. RGSTC does not assume any responsibility of disputes arising out of any of the IPR issues.

4.0 Project Monitoring

The Technical Screening Committee (TSC) will be constituted by RGSTC to monitor the progress of the projects. The monitoring functions of the TSC to be as follows:

- 4.1 Monitoring the progress of the projects and to review the work related to the projects at various stages of completion.
- 4.2 Recommending continuation of the project and or short closure of the project or recommending on other issues related to project from time to time.

5.0 Amendment of the Agreement

No amendment or modification of this Agreement shall be valid unless the same is made in writing by both the parties or their authorized representatives and specifically stating the same to be an amendment of this Agreement. The modification / changes shall be effective from the date on which they are made/ executed unless otherwise agreed to by both the parties shall be liable to return immediately, the unutilized amount within 30 days of such termination.

6.0 Tenure of the Agreement

The agreement shall be effective from the date of signing of the agreement. If Agreement is signed through circulation by post, the date on which RGSTC signs the Agreement shall be considered as effective. The Agreement shall be valid for a period of **three (3) years**. However, if any / some / all of the ongoing projects / activities undertaken by the Academic Partner is / are not complete within **three years** duration, the Academic Partner shall be responsible for their successful completion and settlement of accounts irrespective of the

extension of the agreement. In exceptional cases, RGSTC reserves the right to extend the tenure of the Agreement on the recommendations of the Technical Screening Committee.

7.0 Short closure or Termination

RGSTC reserves the right to short close the scheme or any project with the Academic Partner and terminate the Agreement any time during the agreement period on the ground of under-performance after serving one month written notice to the Academic Partner if RGSTC is convinced that the grant has not been properly utilized or appropriate progress is not being made by the Government College of Engineering, Amravati. In the event of such termination no further disbursement shall be made to the Government College of Engineering, Amravati.

8.0 Force Majeure

Neither party shall be held responsible for non-fulfillment of their respective obligations under this agreement due to the exigency of one or more of the force majeure events such as but not limited to Acts of God, war, flood, earthquakes strike, lockouts, epidemics, riots, civil commotion. etc. provided on the occurrence and cessation of any such events, the party affected thereby shall give a notice in writing to the other party within one month of such occurrence or cessation. If the force-majeure conditions continue beyond six months, the parties shall then mutually decide about the future course of action.

9.0 Notices

All notices and other communications required to be served on **Government College of Engineering, Amravati** including for violation of the terms and conditions of this Agreement shall be considered to be duly served, if the same shall have been delivered by hand or posted by registered mail or speed post to the party at its address as below.

10.0 Dispute Resolution

- 10.1 In the event of any dispute under this Agreement, the parties shall first attempt to resolve such dispute or differences through the good offices of the chief executives of the parties. If the dispute cannot be resolved amicably within 30 days of the receipt of a written notice to resolve the dispute, then, the unresolved dispute or differences shall be referred to the sole arbitration of the Chairman, Rajiv Gandhi Science and Technology Commission, Government of Maharashtra, or that of his / her nominee and his decision shall be final and shall be binding on all the Parties. A reference to the arbitration under this Clause shall be deemed to be submission within the meaning of the Arbitration and Conciliation Act, 1996, and the rules framed there under for the time being in force.
- 10.2 The venue of the Arbitration shall be at Mumbai.
- 10.3 Each Party shall bear and pay its own cost of the arbitration proceedings unless the arbitrator otherwise decides in the award.
- 10.4 The provision of this clause shall not be frustrated, abrogated or become inoperative, notwithstanding this Agreement expires or ceases to exist or is terminated or revoked or declared unlawful.
- 10.5 If the Academic Partner does not make any claim or demand or raise any dispute or difference in terms of Sub Clause "10.1" of this Clause within six months from the date on which such claim or demand arises, the Academic Partner shall deem to have waived and abandoned such claim or demand or the right to raise such dispute or difference against "RGSTC".

11.0 Jurisdiction

Subject to the Dispute Resolution Clause 10.0 hereof the courts at Mumbai shall have exclusive Jurisdiction in all matters concerning this Agreement including any matter arising out of the arbitration proceedings or any award made therein.
